MEMORANDUM OF UNDERSTANDING (MoU)

This memorandum of understanding entered between **GONDWANA UNIVERSITY, GADCHIROLI** and **Shri Jivanrao Sitaram Patil Munghate Arts, Commerce and Science College, Dhanora, Distt. Gadchiroli.**

This agreement is effective as of 28th Sep'2021 for sharing a common desire to explore and strengthen the functional relationship between;

GONDWANA UNIVERSITY, M.I.D.C. Road Complex, Gadchiroli - 442 605, Maharashtra represented herein by Dr. Anil Chitade, Registrar In-charge as executioner of the aforesaid MOU;


Shri Jivanrao Sitaram Patil Munghate Arts, Commerce and Science College, Dhanora, Distt. Gadchiroli, represented herein by Dr Pankaj Rasik Chavhan, I/c Principal as executioner of the aforesaid MOU;

GONDWANA UNIVERSITY, GADCHIROLI and **Shri Jivanrao Sitaram Patil Munghate Arts, Commerce and Science College, Dhanora, Distt. Gadchiroli** and are hereinafter individually referred to as a "**First Party**" and the "**Second Party**", and or institutions, when referred both.

Preamble

WHEREAS, **GONDWANA UNIVERSITY, GADCHIROLI**, a Govt. of Maharashtra University was established in Sep'2011 under the UGC Act'1956, is objected at up-liftment of the under-privileged region encompassing districts of Chandrapur and Gadchiroli of eastern Maharashtra, that is recognized as tribal having majority forested areas by way of expansion, inclusion and excellence. The University is host to **Science and Technology Resource Center (STRC)**, an autonomous institute at **GONDWANA UNIVERSITY, GADCHIROLI** funded by **Rajiv Gandhi Science & Technology Commission (RGSTC), Mumbai**. STRC is positioned as the center of excellence for sustainable value creation and objected at generating livelihood opportunities by deploying appropriate Science & Technology, particularly for the backward and marginalized tribal communities of the Gadchiroli region. It has broad thematic like Aquaculture based Livelihoods, Bamboo for livelihood and Nation Building, Medicinal plants and other Non-Timber Forest Produce, Academic Program development and Incubation.

WHEREAS, **Shri Jivanrao Sitaram Patil Munghate Arts, Commerce and Science College, Dhanora, Distt. Gadchiroli** is an affiliated college of Gondwana University, Gadchiroli imparting various educational programs and engaged in training and research.



WHEREAS, GONDWANA UNIVERSITY, GADCHIROLI and Shri Jivanrao Sitaram Patil Munghate Arts, Commerce and Science College, Dhanora, Distt. Gadchiroli and have many areas of common interest in academics, training, entrepreneurship development, collaborative projects; considerable advantage may be gained from their pursuit on a cooperative basis in the fields of academics, Education, Research/Innovation, Social welfare of the region.

Now, Therefore GONDWANA UNIVERSITY, GADCHIROLI and Shri Jivanrao Sitaram Patil Munghate Arts, Commerce and Science College, Dhanora, Distt. Gadchiroli have decided to enter into this Memorandum of Understanding (hereinafter referred to as MoU), which will define the framework for the cooperation of the institutions set out in following sections.

Article I

Areas of Co-operation



Institutes (i.e. First Party and Second Party) agreed to develop the following collaborative activities in the areas of mutual interest, on the basis of equality and reciprocity.

These institutions shall seek to promote and collaborate in:

1. Training and development:
2. Academic Activities:
3. Research, Innovation and Incubation:
4. Extension Services and Publishing
5. Student / Staff Exchange Programme:
6. Collaborative/Co-operative Projects, Programs and Activities:

Parties will jointly work together with agreed terms and conditions as mentioned in this MoU. The financial commitments on the part of the GONDWANA UNIVERSITY, GADCHIROLI, the First Party and Shri Jivanrao Sitaram Patil Munghate Arts, Commerce and Science College, Dhanora, Distt. Gadchiroli, the Second Party to undertake any activity / programme and services mentioned in the MoU shall be dealt on one-to-one basis. The recurring expenditure, honorariums, admissible allowances, incidental and miscellaneous expenses if any during the programmes undertaken by both the parties based on mutual interest, shall be estimated priorly depending upon utilization of all kinds of resources of both the parties. Similarly the use of resources of both the parties and or as per the terms and conditions agreed between the parties.

As part of agreed terms of this MoU, both the parties shall be subject to maintenance of accounts and audits as per statutory norms as prescribed by the first party, covering all the initiatives and activities undertaken under this MoU.



Article II

Implementation of collaborative/co-operative Projects, Programs and Activities in particular – “Karmayogi Baba Amte Unnat Gram Abhiyan Yojna”.

Specific activities and projects as planned by the first party, of above mentioned collaborative/co-operative project, details of which shall be shared from time to time, are to be executed by and through the second party. The details will include the specific activities to be conducted, responsibilities of co-operating second party; allocation of financial assistance to the second party by the first party, schedules, implementation procedures and other details, as decided by the first party from time to time. The decisions in the regard and procedure to be followed by the first party, shall be binding upon the second party.

Article III

Duration, Termination and Modification of MoU

This agreement shall come into force from the effective date of this agreement and remain in force for the period of 3 years or till the completion of projects undertaken under the purview of article 2 above or unless extended by the mutual consent of the parties in writing. Either party may terminate this agreement with or without assigning any reason by providing 3 months' notice to the other party in writing. Provided though the MoU is dissolved between the parties, the ongoing courses, programmes, assistance for research programmes and allied activities shall continue till finishing conclusion and it is deemed that the accreditation/affiliation is in force during the said period. This agreement may be revised on mutually agreed terms and conditions and the revisions shall be in writing and only become effective on signing by an authorized representative of each party.

Article V

Limitations of Liability and Indemnification

Each party shall indemnify, defend and hold harmless the other party from and against any and all liabilities, damages, loss, claims, suits or judgements and expenses that indemnified party may incur to the extent caused by indemnifying party's fraud, negligence or willful misconduct in performance of its obligations herein or its breach of any term of this agreement or noncompliance with applicable laws of the university and state government from time to time. The first party shall be empowered authority to recover damages due to non-compliance by the second party, as per the relevant laws and norms from time to time.



Article VI

Arbitration


That any differences or divergence derived from interpretation shall be solved by the first party as per its own statutory provisions made in the respect. The decision evolved out so shall be final and binding upon the second party.


